HOW YOU'RE DONATIONS HELPS US MAKE A DIFFERENCE

HOW GIFT AID CAN BOOST YOUR DONATION

If you are a UK taxpayer, under the governments Gift Aid scheme Grace Eyre can reclaim the tax that you pay on any donation. This means we get an extra 28% on top of your donation, at no extra cost to you. So for example:
