

# Terms and conditions for runners of the Brighton Marathon in aid of the Grace Eyre Foundation

#### General

- You will inform the Grace Eyre fundraising team immediately if you are unable to take part in the event.
- Please note that Grace Eyre is not responsible for the organisation or management of the event, and therefore we shall have no liability to you for any injury, damage or loss suffered by you when taking part in or in connection with the event
- You participate in this event at your own risk. Grace Eyre will not be held responsible for any injury or illness resulting from your participation in the event.
- The event won't be covered by Grace Eyre's insurance programme. If appropriate, you will arrange your own insurance and will make sure that contractors and external facilities used can demonstrate evidence or the relevant insurance cover.
- Photos and video footage from the event may be used by Grace Eyre for our website and/or social media channels

### **Data protection**

- When you submit your form, Grace Eyre collects your personal data. Grace Eyre is the data controller for this information.
- You understand that Grace Eyre may use, process and share your personal data for the following reasons:
  - o to send you information about fundraising;
  - o with third parties as is necessary to provide you with the information and materials you need for the event, e.g. event organisers, London Marathon Events;
  - o if you are participating as part of a group, we may pass your details on to other members of that group
  - o if you actively opt into being contacted by Grace Eyre about our work, services and activities;

### **Fundraising**

- You will only use lawful means to fundraise in aid of Grace Eyre and you will not bring the charity's names into disrepute.
- You will observe the following fundraising rules and you will comply with any further rules and requirements about fundraising of which Grace Eyre may notify you.
  - o You must use the expression "in aid of" when fundraising to distinguish your fundraising activity from that of Grace Eyre
  - o You are responsible for organising all aspects of your fundraising and Grace Eyre will not accept any liability relating to your fundraising
  - o Unless donors stipulate conditions, any money raised automatically belongs to Grace Eyre whether or not the activity is completed.



- o If donors stipulate conditions and you are unable to meet those conditions (e.g. complete the event), it is your responsibility to contact the donors to ask if they are happy for their donation to still go to Grace Eyre and issue refunds if they are not.
- Grace Eyre will provide support to set up fundraising pages on recognised fundraising sites JustGiving and GoFundMe
- Grace Eyre will provide support to help promote your fundraising efforts.

## **Donations and Payment Terms**

- I pledge to raise a minimum of £500 excluding Gift Aid and registration fee.
- Pay a non-refundable and non-transferable registration fee of £35 (including VAT).
- I will endeavour to raise as much as possible for Grace Eyre and will regularly pay all money collected to the charity by using a fundraising website such as Enthuse, JustGiving or GoFundMe
- I will send all outstanding sponsorship money to Grace Eyre no later than 7th May 2024
